
Estimated Cost of K-12 Public Education for Unaccompanied Alien Children

According to data from the Department of Health and Human Services, more than 37,000 of the unaccompanied illegal alien minors from the border crisis were released to relatives and other sponsors between January 1 and July 31.

Based on earlier estimates of the cost of educating LEP students in public schools, we came up with an estimate of how much it will cost taxpayers in each state to educate illegal alien minors in the coming school year.
