

## Congressional Voting Report | 109th Congress U.S. HOUSE OF REPRESENTATIVES



FAIR's Congressional Voting Report is designed to help you understand a U.S. representative's support for immigration measures to strengthen or weaken immigration control during the 109th Congress. We have chosen votes of thirteen immigration-related bills as the benchmarks for assessing stances. Where a member voted on a bill that FAIR supports, you will see a green plus sign (+). Where a member voted for a bill that FAIR opposes, you will see a red minus sign (-). Where a member did not vote, you will see (NV).

### H.R. 418: REAL ID Act of 2005

#### **House Vote 31**

February 10, 2005 — Passage of the bill would set national standards for state driver's licenses and identity cards. In addition, H.R. 418 modifies asylum/refugee laws by allowing immigration judges to weigh the credibility of asylum applicants in a variety of proceedings and removing the annual cap of 10,000 refugees who may become permanent residents. The bill also authorizes the Department of Homeland Security to include information on anyone convicted of using a false driver's license to board an airplane in aviation security screening databases. Passed 261-161. **FAIR supports this bill.**

### H.R. 2360: Fiscal Year 2006 Homeland Security Appropriations

#### **House Vote 177, Immigration**

May 17, 2005 — Tancredo (R-CO) amendment #138 to H.R. 2360 would prohibit the use of FY06 Homeland Security funds to assist state or local governments that have restrictions on exchanging information with Immigration and Customs Enforcement (ICE) on an individual's citizenship or immigration status. Rejected 165-258. **FAIR supports this amendment.**

### H.R. 2862: Fiscal 2006 Commerce/Justice/Science Appropriations

#### **House Vote 262, Immigration Standards**

June 16, 2005 — Tancredo (R-CO) amendment #288 to H.R. 2862 that would prohibit the use of State Criminal Alien Assistance Program funds by state or local governments that restrict their officials from sharing immigration status to the Department of Homeland Security. Rejected 204-222. **FAIR supports this amendment.**

#### ***House Vote 267, Illegal Immigration***

June 16, 2005 — King (R-IA) amendment #281 to H.R. 2862 provides \$1 million for enforcement of subsections (a) and (b) of section 642 of the Illegal Immigration Reform and Immigrant Responsibility Act of 1996. Those paragraphs prohibit localities from preventing police officers from asking or reporting immigration information to the Federal government. The increased appropriation would be offset by a reduction in salaries, expenses and general legal activities at the Justice Department. Adopted 218-208. **FAIR supports this amendment.**

#### **H.R. 6061: Secure Fence Act of 2006**

##### ***House Vote 446***

September 14, 2006 — Passage of the bill would direct the Secretary of Homeland Security, within 18 months of enactment of this Act, to take appropriate actions to achieve operational control over international land and maritime borders of the United States. The bill requires the Department of Homeland Security to construct approximately 700 miles of fence along the U.S.-Mexico border and to study the feasibility of constructing fencing along the northern border. H.R. 6061 also directs Homeland Security to re-evaluate the authority border patrol agents have to stop fleeing vehicles and to recommend appropriate changes to border patrol policy. Passed 283-138. **FAIR supports this bill.**

#### **H.R. 6094: Community Protection Act of 2006**

##### ***House Vote 465***

September 21, 2006 — Passage of the bill would restore the Department of Homeland Security's authority to detain dangerous aliens, as defined and under certain circumstances, beyond the current limitation of six months. H.R. 6094 also allows the Department of Homeland Security to apply expedited removal to criminal aliens and provides that alien gang members are inadmissible and deportable. Passed 328-95. **FAIR supports this bill.**

#### **H.R. 6095: Immigration Law Enforcement Act of 2006**

##### ***House Vote 468***

September 21, 2006 — Passage of the bill would reaffirm that state and local law enforcement personnel have the inherent authority to investigate, identify, arrest, and detain aliens in the normal course of duties for the purpose of assisting enforcement of U.S. immigration laws. The bill encourages the Department of Justice to adopt uniform guidelines for the prosecution of alien smuggling offenses. It also places limitations on how courts can order prospective relief (i.e. injunctions) in immigration cases. Passed 277-140. **FAIR supports this bill.**

#### **H.R. 5441: Fiscal Year 2007 Department of Homeland Security Appropriations**

##### ***House Vote 509, Illegal Immigration***

September 29, 2006 — Passage of FY07 Homeland Security Appropriations conference committee report. Because the conference report contained measures that were both positive and negative, **FAIR is not taking a position on this vote.** However, FAIR has included it in

this report to inform readers how members voted. H.R. 5441 appropriates \$1.2 billion for border fencing, surveillance and technology, but falls short of the minimum of \$1.8 billion needed to fully fund the 700 miles of fence required by the Secure Fence Act of 2006. H.R. 5441 also appropriates money for an additional 1,500 border patrol agents and 6,700 detention beds. The bill criminalizes the construction of border tunnels but also delays the implementation of the Western Hemisphere Travel Initiative. Passed 412 – 6. Because the Senate passed the FY07 DHS appropriations conference committee report by voice vote, a corresponding vote is not included in the Senate voting report analysis.

## **H.R. 4437: Border Security**

### ***House Vote 640, Security Fencing***

December 15, 2005 — Hunter (R-CA) amendment #648 to H.R. 4437 would require the Department of Homeland Security to construct approximately 700 miles of security fencing and install lights, cameras and additional vehicle barriers along the U.S.-Mexico border. Adopted 260-159. **FAIR supports this amendment.**

### ***House Vote 653, Diversity Visa Program***

December 16, 2005 — Goodlatte (R-VA) amendment #650 to H.R. 4437 would eliminate the diversity visa program, otherwise known as the visa lottery. The diversity visa program sets aside 50,000 permanent resident visas (green cards) annually, but issues them randomly to eligible applicants instead of pursuant to an analysis of the alien's skill level or potential contribution to society. Adopted 273-148. **FAIR supports this amendment.**

### ***House Vote 656, Illegal Aliens***

December 16, 2005 — Norwood (R-GA) amendment #658 to H.R. 4437 would reaffirm the authority of state and local law enforcement agencies to enforce immigration laws. The amendment also directs the Department of Homeland Security to provide training on the enforcement of immigration laws to state and local law enforcement agencies at no cost. In addition, the amendment provides additional resources (SCAAP grants, Institutional Removal Program, and a new grant program) to help assist in the enforcement of immigration laws and requires the Department to input the names of certain alien offenders into the National Crime Information Center database. Adopted 237-180. **FAIR supports this amendment.**

### ***House Vote 659, Deportation of Illegal Aliens***

December 16, 2005 — Sullivan (R-OK) amendment #667 to H.R. 4437 would reaffirm the authority of state and local law enforcement agencies to detain illegal aliens for the purpose of enforcing immigration laws. The amendment would also require Federal authorities to take custody of all illegal aliens upon request by state and local law enforcement and to reimburse state and local governments for the cost of detention and transportation. In addition, the amendment would expand the use of expedited removal nationwide for all illegal aliens who cannot prove to the immigration officer they have been in the United States for more than one year. The amendment would also require that by 2008, all non-citizens who enter or exit the country be processed through an automated entry-exit control system that Congress mandated in 1996 (US-VISIT). Rejected 163-251. **FAIR supports this amendment.**

***House Vote 661, Passage***

December 16, 2005 — Passage of the bill would tighten border security and increase enforcement of immigration laws. H.R. 4437 would designate unlawful presence as a criminal, rather than a civil, offense. It also would increase penalties for a variety of immigration-related crimes. It would create a mandatory program under which all employers would have to electronically verify employees' work eligibility with the federal government (via the Basic Pilot Program). As amended, it would require the construction of security fencing, including lights and cameras, along approximately 700 miles of the U.S.-Mexico border. Passed 239-182. **FAIR supports this bill.**
