Congressional Voting Report

112th

FAIR's Congressional Voting Report is designed to help you understand the positions that each U.S. Representative has taken on immigration measures during the 112th Congress in furtherance of a rational immigration system. What is noteworthy about the 112th Congress is that it has passed fewer bills than any other Congress since World War II. Nevertheless, we have chosen several immigration-related votes on appropriations, border security, and legal immigration to present a picture of each Representative's position. Where a Representative voted with FAIR's position on an amendment or bill, you will see a green plus sign (+). Where a Representative voted against FAIR's position, you will see a red minus sign (-). Where a Representative did not vote, you will see (NV). During any period that a Representative was not in office, you will see (NP).

H.R. 915

Jaime Zapata Border Enforcement Security Task Force Act

House Vote 296, Border Security | May 30, 2012—Rep. Henry Cuellar (D-TX) sponsored H.R. 915, legislation that authorizes the appropriation of \$10 million for each of the fiscal years 2012 through 2016 for the Border Enforcement Security Task Force (BEST) program within the Department of Homeland Security. Under the BEST program, personnel from federal, state, local, tribal, and foreign law enforcement agencies share information and carry out law enforcement operations to combat criminal activity near United States borders. The bill passed 391-2. **FAIR supported H.R. 915.**

H.R. 1933

Bill to Bring Foreign Nurses to “Health Professional Shortage Areas”

House Vote 685, Legal Immigration | Aug. 1, 2011—Rep. Lamar Smith (R-TX) sponsored H.R. 1933, legislation that would reinstate an expired program that admits nonimmigrant nurses to work in “health professional shortage areas.” The program, which expired in 2009, provided for 500 nonimmigrant visas each fiscal year to aliens who obtained a nursing license, passed the

requisite exam, and were otherwise eligible for admission. Similarly, H.R. 1933 would allow the government to issue 300 visas annually to eligible foreign nurses. At the end of this initial period, admitted nurses can seek to renew their visa for an additional three years. Under the bill, visa recipients may also accept new employment as a nurse upon the successful petition of a new hospital employer. The bill passed 407-17. **FAIR opposed H.R. 1933.**

H.R. 2017

Department of Homeland Security Appropriations Act, Fiscal Year 2012

H.R. 2017 was the annual funding bill through which Congress appropriated money to the Department of Homeland Security (DHS) and its agencies, including Immigration and Customs Enforcement (ICE), U.S. Citizenship and Immigration Services (USCIS), and Customs and Border Protection (CBP). Funding is used to pay for the salaries and expenses of all DHS employees, as well as all programs implemented by the department. House Members introduced dozens of amendments to this bill, several of which were voted on by voice vote, making it impossible to determine which Members voted for or against the amendment. **However, below is a listing of the key amendments FAIR supported or opposed that received a roll call vote:**

House Vote 385, Border Security | June 1, 2011—Rep. David Cicilline (D-RI) amendment H.AMDT.350 to decrease funding for Border Security, Fencing, Infrastructure, and Technology by \$337 million and reallocate that funding for state and local grants. The amendment was rejected 154-266. **FAIR opposed H.AMDT.350.**

House Vote 386, Immigration and Customs Enforcement | June 1, 2011—Rep. Ed Royce (R-CA) amendment H.AMDT.351 to increase funding for ICE by \$1 million, offset by reducing funds for Homeland Security Department Executive Management. The amendment was passed 268-151. **FAIR supported H.AMDT.351.**

House Vote 387, Border Security | June 1, 2011—Rep. Ted Poe (R-TX) amendment H.AMDT.354 to increase funding for border security fencing and infrastructure by \$10 million, offset by reducing funds for the Office of the Secretary for Management. The amendment was adopted 327-93. **FAIR supported H.AMDT.354.**

House Vote 388, Border Security | June 1, 2011—Rep. Henry Cuellar (D-TX) amendment H.AMDT.363 to increase funding for the CBP Air/Marine Interdiction, Operations, Maintenance, and Procurement account by \$32 million, offset by reducing funds for the Office of

Undersecretary and Management and the Science and Technology Administration accounts. The amendment was rejected 162-256. **FAIR supported H.AMDT.363.**

House Vote 398, Immigration and Customs Enforcement | June 2, 2011—Rep. Chip Cravaack (R-MN) amendment H.AMDT.393 to prohibit the use of funds by ICE to process the release of, or to administer alternative forms of detention to, illegal aliens who committed a crime mandating their incarceration. The amendment was passed 289-131. **FAIR supported H.AMDT.393.**

House Vote 407, 287(g) | June 2, 2011—Rep. Jared Polis (D-CO) amendment H.AMDT.407 to prohibit the use of funds from being used to carry out the 287(g) immigration enforcement program. The 287(g) program allows ICE to “deputize” or cross-designate state and local law enforcement officers to act as immigration agents within their jurisdictions. The amendment was rejected 107-313. **FAIR opposed H.AMDT.407.**

H.R. 4119
Border Tunnel Prevention Act

House Vote 256, Border Security | May 16, 2012—Rep. Silvestre Reyes (D-TX) sponsored legislation that makes it a federal crime to attempt or conspire to use, construct, or finance underground tunnels that bypass U.S. international borders. Penalties for attempt and conspiracy are the same as existing penalties for use, construction, and financing of border tunnels. The bill also amends existing federal law to add activities “relating to construction or use of international border tunnels” to the list of offenses which can be investigated via wiretapping by federal agencies. The bill was passed 416-4. It became Public Law 112-418. **FAIR supported H.R. 4119.**

H.R. 5855
Department of Homeland Security Appropriations Act, Fiscal Year 2013

H.R. 5855 was the annual funding bill through which Congress appropriated money to the Department of Homeland Security (DHS) and its agencies, including Immigration and Customs Enforcement (ICE), U.S. Citizenship and Immigration Services (USCIS), and Customs and Border Protection (CBP). Funding is used to pay for the salaries and expenses of all DHS employees, as well as all programs implemented by the department. House Members introduced dozens of amendments to this bill, several of which were voted on by voice vote, making it

impossible to determine which Members voted for or against the amendment. **However, below is a listing of the key amendments FAIR supported or opposed that received a roll call vote:**

House Vote 352, Border Security | June 6, 2012—Rep. Ted Poe (R-TX) amendment H.AMDT.1238 to transfer \$10 million from the Office of the Undersecretary for Management to Border Security Fencing, Infrastructure, and Technology for border cell phone service. Most areas along the border are rural and lack wireless communication capabilities, creating a risk to public safety. By increasing the funding for this technology, the amendment would help strengthen communication between border state residents and law enforcement. The amendment was adopted 302-113. **FAIR supported H.AMDT.1238.**

House Vote 363, Administrative Amnesty | June 7, 2012—Rep. Steve King (R-IA) amendment H.AMDT.1266 to prohibit DHS from using money appropriated under the bill to finalize, implement, administer, or enforce the Morton Memos. The term Morton Memos refers to a series of memos issued by ICE Director John Morton that undermine enforcement of U.S. immigration law by directing ICE agents to ignore U.S. law under certain circumstances. The amendment was adopted 238-175. **FAIR supported H.AMDT.1266.**

House Vote 366, 287(g) | June 7, 2012—Rep. John Sullivan (R-OK) amendment H.AMDT.1270 to prohibit DHS from using money appropriated under the bill to terminate a 287(g) agreement between ICE and a local law enforcement agency. The 287(g) program allows ICE to “deputize” or cross-designate state and local law enforcement officers to act as immigration agents within their jurisdictions. Since taking office, President Obama’s Administration has worked to dismantle the 287(g) program, including seeking to cut the program by 25 percent in its 2013 budget proposal and calling for an end to all task-force model agreements under the program. The amendment was adopted 250-164. **FAIR supported H.AMDT.1270.**

House Vote 368, Reduction in Funding | June 7, 2012—Rep. Jared Polis (D-CO) amendment H.AMDT.1274 to cut funding to immigration enforcement programs under the DHS appropriations bill by two percent. Key programs that would have received funding cuts under this amendment include border security fencing, infrastructure, and technology; 287(g); Secure Communities; E-Verify; US-VISIT; and detention and removal operations. The amendment was rejected 99-316. **FAIR opposed H.AMDT.1274.**
